

Wait! Before You Press Send! Email Etiquette for CASA Advocates

CASA advocates frequently use email as a primary mode of communicating with professionals and service providers about their cases. Electronic communication, like other forms of communication, should be conducted in a professional manner.





- 1) Emails pertaining to CASA related business should be professional in tone, language, and content. **Remember, email is subject to discovery.**
- 2) Before you press "send", review your email for appropriateneses. If you are not sure about the lanuage, tone, or content of your email, **do not send the email!** Contact your CASA Casework Supervisor for guidance.
- 3) Decide if the message you want to communicate is appropriate for email, or if what you are trying to communicate requires face-to-face or phone contact,

particularly if what needs to be communicated is complex or difficult.

If you have any concerns or questions, do not hesitate to contact your CASA Casework Supervisor.
