As we prepare for the upcoming holiday season, I am overwhelmed at the many sad, scary and disturbing news headlines these days with natural disasters, mass shootings, sex scandals and more. However, I am even more over-

whelmed at the sad, scary and disturbing headlines that you never see. The headlines that are the reality of children in our community who are abused and neglected at the very hands of those who are supposed to nurture, love and protect them. Our local communities are fortunate to have some courageous people who stand up for these children - CASAs (Court Appointed Special Advocates). These are community volunteers who provide life altering, court advocacy services for children in the worst situations - those who have been removed from their homes and placed in foster care because of the severe abuse or neglect they suffered at home. In 2016, 189 volunteer child advocates provided critical advocacy services to 583 children; and more volunteers will serve more children in 2017. AND...there are still more children needing CASA's services. They need your help! These children's futures are in jeopardy because of a system that desperately needs your voice and your support. We invite each and every person to stand up for a child. There are lots of ways to help. CASA Advocacy at its Best

Kyle entered the care of Texas Child Protective Services (CPS) at age 16 after being kicked out of his home because his mother was unable and unwilling to meet his needs. The mother had previous CPS cases in Michigan and Kyle had been in and out of foster homes in Michigan since his birth. Kyle's father had extensive criminal history and was not involved in his life at all.

Since being placed with CPS 2 $\frac{1}{2}$ years ago, Kyle has been in three different residential treatment centers, five different school districts, and admitted to a psychiatric hospital at least four times. He was also incarcerated in the juvenile justice system for a period of time.

During his entire time in foster care, Kyle has had one CASA advocate – Ron. Ron was available as Kyle navigated all the different placements and changes. As Kyle's 18th birthday was approaching, Ron was inquiring with CPS about placement options for him to stay in foster care beyond 18, as Kyle was willing to do so and knew he needed the extended help. Kyle had yet to finish high school. The CPS caseworker hadn't identified any appropriate relatives, foster homes, or treatment facilities that would accept Kyle because of his behavior problems and CASA was told Kyle would be transported to a homeless shelter on his 18th birthday.

This simply was and is not acceptable to CASA. CASA, the attorney on the case, and even the CPS worker knew that if left to fend for himself at only 18 years old, Kyle would end up in a gang, jail or dead. The CASA Advocate asked the judge to order a psychological evaluation be completed for Kyle to determine if there are any mental diagnoses and an independent living skills assessment that could possibly make him eligible for extended care options. Once done, it shed light on Kyle's serious needs.

Ron, the CASA advocate, reached out to the clinic that performed the psychological evaluation and was given some suggestions for possible treatment centers for Kyle. One was identified that would

accept and help him and one day before his 18th birthday, Kyle was transferred to a treatment facility that could address his problems and help him work toward independent living skills for the future.

This is one example of CASA advocacy at its best and how desperately critical our work with teens can be and the futures it can change.
