## Sheri Littrell's Bold Journey as a CASA Advocate

When Sheri Littrell became a CASA advocate, she didn't know what to expect. She did know that there was a vulnerable group of kids, and she wanted to help. She admits there have been times during her CASA journey when she felt apprehensive—not knowing what behaviors or situations she would walk into, but she showed up anyway. "The unknown can be scary," she said, "but you do it anyway because that's what is needed."


# A MESSAGE FROM OUR EXECUTIVE DIRECTOR

She visited them in moments when they felt scared and alone. She brought crafts, stickers, and comfort. She brought consistency and care.

One of her most impactful moments came when a child's placement was about to fall through. Sheri didn't wait for someone else to solve the problem. She picked up the phone and tracked down extended family in another state, who were thrilled to reconnect and welcomed the child into a loving, permanent home. That connection had been sitting on a list, but Sheri made it real.

Her story is a reminder that being a CASA is not about having all the answers. It's about being willing to take the next step, even when the path is unclear. That same principle applies to CASA of Denton County.

We don't know what the ever-changing child welfare system will look like in the future, what funding will continue to be available, or how many children will experience abuse and need a CASA. We do know that we must be ready to move forward with courage and purpose. Just like Sheri, we must be bold enough to step in and say, "I'll be there."

And we don't do it alone. When our community walks alongside us by volunteering or donating, we are empowered to meet uncertainty with action.
