2021, CASA ANNUALLY SERVES 600 CHILDREN WHO, THROUGH NO FAULT OF THEIR OWN, BECAME  
PART THE LOCAL CHILD WELFARE SYSTEM DURING THE YEAR. 250 CITIZENS ANNUAL SERVE AS
